P) DOCKET NO. 991631-GU - Application by the Florida Division of Chesapeake Utilities Corporation (the Company) for authority to issue up to six million shares of Chesapeake common stock; up to one million shares of Chesapeake preferred stock; and up to \$80 million in secured and/or unsecured debt. In addition, the Company requests authority to exceed the limitation placed on short-term borrowing by Section 366.04, Florida Statutes, so as to issue short-term obligations in an amount not to exceed \$40 million. This security application covers the twelve-month period ending December 31, 2000.

Recommendation: The Commission should approve the action requested in the dockets referenced above and close these dockets, with the exception of Docket No. 991631-GU, which should remain open for monitoring purposes until April 15, 2001.
