BY THE COMMISSION:


On March 16, 2000, we issued Order No. PSC-00-0543-PAA-TP. Due to a scrivener's error, the Order inadvertently failed to reflect that Commissioners Deason and Clark dissented from the majority's decision on the issues relating to mandatory implementation of thousand block number pooling; the implementation date and software release that should be implemented in the 954, 561, and 904 area codes; and the designation of a pooling administrator for the 954, 561, and 904 area codes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-00-0543-PAA-TP is hereby amended to reflect the Commissioners' dissents as discussed in the body of this Order. It is further
