Order No. PSC-99-2205-PAA-TC was issued on November 9, 1999. The company had until November 30, 1999 to protest. No protest was received, therefore, on December 3, 1999, the Consummating Order was issued, which canceled the company's certificate effective that date.

On December 8, 2000, Mr. Moises Rodriguez, President, called me and advised that a collection agency had contacted him concerning the 1998 and 1999 regulatory assessment fees. He stated that when he paid his 1997 RAF, he wrote a note on the check and the RAF form requesting cancellation. Mr. Rodriguez subsequently provided me with a copy of his cancelled check, front and back, which supports his statement.

I then requested a copy of this company's 1997 RAF form from the Commission's Division of Administration. I received the copy of the 1997 RAF form, and it also shows that Mr. Rodriguez requested cancellation. Due to a clerical error, technical staff was not provided a copy of the company's request for cancellation.

After discussing with Legal, it was decided that this docket should be reopened so that staff can take this docket back to Agenda to vacate Order No. PSC-99-2205-PAA-TC and grant this company a retroactive inactive date of 12/31/97. Accordingly, please reopen this docket. I will revise the CASR. Let me know if you have any questions.
