

**Second Agreed Motion for Extension of Time**

ITC^DeltaCom Communications, Inc., d/b/a ITC^DeltaCom ("ITC^DeltaCom"), and BellSouth Telecommunications, Inc., ("BellSouth"), submit this Second Agreed Motion for Extension of Time ("Motion") and in support state as follows:

1. On November 22, 2000, the Commission issued its Final Order on Arbitration, Order No. PSC-00-2233-FOF-TP, in this proceeding. Therein, the Commission ordered the parties to submit a signed interconnection agreement compliant with its decisions within twenty days of the issuance of the Final Order.
2. On December 12, 2000, the parties submitted a joint Agreed Motion for Extension of time to January 11, 2001, to submit a signed interconnection agreement.
2. The parties are still in the process of finalizing the interconnection agreement. On January 10, 2001, BellSouth's office contacted ITC^DeltaCom and requested that ITC^DeltaCom file a second request for extension of time.
3. ITC^DeltaCom is authorized to represent that BellSouth joins in and consents to this motion. Thus, the parties hereby request that the Commission grant an extension of time to February 12, 2001 for filing the interconnection agreement.
