On behalf of Teleglobe Business Solutions, ("TBS" or "Company"), this letter is to notify the Florida Public Service Commission ("Commission") of the Company's intention to change its name to eMeritus Communications, Inc. ("eMeritus"). A copy of the Amended Certificate of Authority to Transact Business in the State of Florida is attached hereto as Exhibit A. Also enclosed as Exhibit B for the Commission's reference is a copy of the notice that TBS will provide to each of its customers to advise them of the name change.

By way of background, TBS provides telecommunications services in the State of Florida pursuant to certificate No. 3496 (IXC) and 4699 (ALEC). 


