- 3. <u>Statement of Substantial Interests</u>. Covad is a provider of x DSL services. It provides high-speed Internet and network access utilizing digital subscriber line (DSL) technology. Covad offers DSL services through Internet Service Providers (ISPs) to small and medium-sized businesses and home users and directly to companies who use DSL to enable their employees to connect with their businesses' internal computer networks (or Local Area Networks) from their homes. In Florida, Covad provides services to residential consumers and businesses in Miami, Orlando, Tampa and Jacksonville.
- 4. In providing its service offerings, Covad must purchase unbundled network elements (UNEs) from incumbent local exchange carriers, such as BellSouth, GTE, and Sprint, and must provision those UNEs through use of the incumbent local exchange carriers' operations support systems (OSS). Therefore, performance metrics set by the Commission in this proceeding will directly and substantially affect Covad's ability to provide service to Florida consumers. Therefore, Covad has an important and substantial interest in this proceeding.
- 5. <u>Statement of Material Facts in Dispute</u>. Petitioner is unable to identify disputes of material fact at this time.
- 6. <u>Ultimate Facts Alleged.</u> Comprehensive and effective performance measures are essential to ensure that ALECs receive nondiscriminatory access to OSS systems.

WHEREFORE, Covad requests that its Petition to Intervene be granted and that it be accorded full party status in this docket.
