The first is voluntary and is requested by the certificate holder. The Commission grants voluntary cancellations if a company is in good standing and has paid the Regulatory Assessment Fee. The other is involuntary. This is where the Commission cancels a certificate for a rule violation, such as not paying the Regulatory Assessment Fee. If the Commission cancels a certificate involuntarily, any unpaid fees, including penalty and interest charges, are forwarded to the Comptroller's Office for collection attempts. I'm enclosing a copy of Rule 25-24.514, Florida Administrative Code, for your review.

Although you may have sold your business in 1999, the Commission was not advised, therefore, the Regulatory Assessment Fee is owed for the year 2000.
