BellSouth Telecommunications, Inc. will conduct a tour of its Atlantic RSM Central Office on Friday, January 26, 2001 at 10:00 a.m. E.S.T. as required in the above-referenced docket. Parties and interested persons are asked to send no more than two representatives for the tour. The central office is in Jacksonville, Florida, at 13635 Atlantic Boulevard. Directions are as follows:

#### From Tallahassee, Florida:

- \* Step 1: Take I-10 East to Jacksonville, Florida (I-10 East will dead end into I-95)
- \* Step 2: Take I-95 North, EXIT on Union Street (keep straight and go across the Matthews
- Bridge). Union Street will become Arlington Expressway and dead end into Atlantic Blvd.
- \* Step 3: KEEP Straight on Atlantic Boulevard- Travel approximately 6 miles
- \* Step 4: After the intersection of Atlantic Blvd and San Pueblo Road- Travel approximately 120 feet (Go thru traffic light which is the intersection of San Pueblo Road and Atlantic Blvd.)
- \* Step 5: Make LEFT at median in the Road, the address is 13635 Atlantic Boulevard, location of the Atlantic RSM BellSouth Central Office

#### From Jacksonville International Airport:

- \* Take I-95 South
- \* Take SR 9A (Exit going East)- Follow Signs to Daimes Point Bridge
- \* Go across Daimes Point Bridge (once you cross the bridge, you will be on Gilmore Heights Road)
- \* Keep Straight (go across a big overpass)
- \* At the bottom of the overpass, Turn Left onto Atlantic Boulevard/Arlington Expressway
- \* REPEAT Steps 3-5 above
