BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Notice of Intent to Request Specified Confidential Classification for the data request on LEC/CLEC procedures for connecting former ILEC or CLEC customers.

1. In a letter dated January 9, 2001, the Florida Public Service Commission ("Commission"), requested BellSouth to provide written procedures for connecting new BellSouth customers switching their local service from a CLEC. This information is being given in connection with an informal investigation of LEC/CLEC procedures conducted by the Commission.

2. The information contained in BellSouth's response is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes Section 364.183.
