



EXECUTIVE SUMMARY

RECOMMENDATION TO AWARD BID #00-3136 – "ANNUAL CONTRACT FOR SODIUM HYPOCHLORITE SOLUTION"

<u>OBJECTIVE</u>: That the Board of County Commissioners, Ex-Officio, the Governing Board of the County Water/Sewer District, award Bid #00-3136 – "Annual Contract for Sodium Hypochlorite Solution" to control odor caused by hydrogen sulfide and organic gasses at the water treatment and wastewater reclamation facilities.

CONSIDERATION:

- 1. The County's Public Works Division operates water and wastewater facilities necessary to serve the customers of the County Water/Sewer District.
- 2. These facilities provide treatment of the County's water and sewage and a byproduct of such treatment can be odorous hydrogen sulfide and organic gasses
- Bid #00-3136 "Annual Contract for Sodium Hypochlorite Solution" was posted on August 4, 2000. Eighty-eight (88) inquiries were sent to vendors. Five (5) packages were received. All legal requirements have been met.
- 4. Staff has reviewed the bids received and recommends that the lowest, qualified and responsive bidder is Allied Universal Corp.

<u>GROWTH MANAGEMENT IMPACT</u>: There is no growth management impact associated with this item.

FISCAL IMPACT: The fiscal impact of awarding this bid is in the estimated amount of \$226,560.00. Funds are budgeted and approved in the Collier County Water/Sewer District North and South Water Treatment Plants, and North and South Wastewater Treatment plants plant budgets.
