

Subject: Docket No. 010102-TP (Tampa Rate Center)

This letter is in response to your January 26, 2001 letter. Verizon strongly disagrees that it has refused to comply with the request in your November 17, 2000 letter.

As stated in my January 24, 2001 letter, Verizon is a member of an industry forum for the discussion on issues regarding RDBS (Routing DataBase System which is the Telcordia system that houses NPA-NXX code information) called CIGRR (Common Interest Group on Routing and Rating). In April 1999, in response to the ongoing industry concerns posed at CIGRR, GTE broke out the localities for their codes to reflect in which of the existing five-tariffed Tampa rate centers the code resided.

As stated in my prior letter, the industry effort was to make the LERG consistent with GTE's tariffs. The due date for the conversion was determined in compliance with all current industry guidelines. On August 17, 2000, letters were drafted and sent via registered mail or registered e-mail to all OCNs with the Tampa area by GTE under their new Verizon letterhead. At that time, the new rate center names and localities were requested by Verizon to be built in RDBS by Telcordia. Verizon also went ahead and made all the required changes to their NXXs with the planned effective date of February 1, 2001. Under industry guidelines (which were discussed in Mr. Self's January 23, - 2001 letter), changes must be made at least 66 days prior to the effective date.

In Mr. Self's October 25, 2000 letter, the ALECs requested a delay in the proposed Tampa rate center changes until May 1, 2001 to allow the ALECs additional time to complete their analysis. Verizon stated that if the FPSC requested such a delay, Verizon would be willing to accommodate the ALECs' request to delay implementation of the changes for their codes. A meeting was held with FPSC staff and various ALECs on November 13, 2000 to discuss the Tampa rate center situation. After the meeting, Verizon contacted Sally Simmons to let the FPSC staff know that Verizon had already made all the changes to the LERG to be effective February 1, 2001, and we did not want to undo the changes that had been made. Verizon has approximately 120 NXX codes in the Tampa rate center and these changes were not really changing anything for the Verizon codes. However, we committed to work with the industry to allow the ALECs to continue the use of the nonidentified Tampa rate center for a longer period of time. This discussion led to the November 17, 2000 letter.

Verizon's interpretation of the November 17th letter was that the date when the ALECs would be required to convert their codes was indefinitely delayed. As a result, Verizon worked with both Neustar and Telcordia to insure that the ALECs could continue to use the nondesignated Tampa rate center designation. The only concern was that Neustar has requested a finalized date of when compliance would be due for any <u>new</u> NXX assignments. They have not agreed to an indefinite push out. In accordance with your letter, the only change that Verizon requested was to defer the February 1, 2001 requirement for conversion of the ALECs' codes and implementation of the requirement to designate only the five Tampa rate centers effective February 1, 2001. Verizon has not given Telcordia or Neustar any other dates to utilize. The May 1 and July 1 dates in my letter were strictly a recommendation for the FPSC staff to consider since we did not have an established docket at that time dealing with the Tampa rate center and I did not send my letter to Telcordia or Neustar.

As a result of your January 26, 2001 letter, Verizon did contact Telcordia to determine if they could eliminate the Verizon changes that were scheduled to be effective February 1, 2001. However, we discovered a number of problems with this approach which we then discussed with Bob Casey. Due to the normal industry procedures, the TPM (terminating point master file) was sent to all carriers on January 25, 2001 with all the known changes in the LERG (also had other changes than the Tampa rate center). The only update that many carriers get for LERG changes is from the TPM file and they receive updates every 30 or 60 days. As a result, if Verizon attempted to eliminate the changes, many carriers might not get the notification for 60 days. Under emergency conditions, the quickest that changes can be made in the LERG is on five days notice. However, any carrier that does not get the emergency updates would not be aware until

they received the TPM. In addition, Telcordia notified Verizon and the FPSC staff that other carriers also had changes reflecting the five Tampa rate centers. Therefore, there was no way that Verizon could eliminate the changes (and the changes are consistent with the LERG information that has been there since April 1999 and is reported on Schedule 19).

In accordance with the staff recommendation that was approved at the February 6, 2001 agenda, Verizon will be using the five Tampa rate centers for any new NXX codes that are established prior to the conclusion of Docket No. 010102-TP. Any required changes as a result of the Commission's decision in this docket will be done in accordance with the decision.
