In addition, Cellular One of Southwest Florida intends to continue discussions with staff until a mutual settlement agreement can be reached. In discussions with Cellular One of Southwest Florida, staff's initial assessment is that the company and staff will be able to resolve the issues of the show cause proceedings. In view of Cellular One of Southwest Florida's request for deferral (attached) and its intention to continue settlement discussions, staff supports the request for deferral.
