## CASE BACKGROUND

On October 20, 2000, Digital Broadband Communications, Inc. (Digital) filed an application for certificate to provide interexchange telecommunications (IXC) services. At the December 19, 2000, Agenda Conference, the Commission approved Digital's application for certificate to provide IXC services. On January 9, 2001, a PAA Order was issued granting the application to provide IXC services. On January 24, 2001, Digital filed a letter requesting that its application for certificate to provide IXC services be withdrawn.

The Commission is vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

## DISCUSSION OF THE ISSUES

**ISSUE 1:** Should the Commission vacate Order No. PSC-01-0074-PAA-TI, issued January 9, 2001, granting Digital Broadband Communications, Inc., a certificate to provide IXC services?

**RECOMMENDATION:** Yes. The Commission should vacate Order No. PSC-01-0074-PAA-TI.

**STAFF ANALYSIS:** As stated in the case background, Digital requested withdrawal of its application for certificate to provide IXC services. Since Digital has requested withdrawal of its application to provide IXC services, staff is recommending that Order No. PSC-01-0074-PAA-TI be vacated.
