On behalf of PaeTec Communications, Inc. ("PaeTec"), this letter responds to Commission
Order No. PSC-01-0164-PAA-TP, issued in the above referenced docket ("Order"). Please date-

provided.

By way of background, PaeTec and East Florida Communications, Inc. ("EFC") were recently
merged as part of an intra corporate merger, which was approved by the Commission in the Order.
The Order directs EFC to return its Certificates No. 51 (IXC) and No. 4796 (ALEC) to the
Commission. PaeTec, as the survivor of the merger, files this response to comply with the Order.
Despite its efforts, PaeTec has been unable to locate IXC Certificate No. 51 and ALEC Certificate
No. 4796 among its records. Therefore, PaeTec hereby notifies the Commission that it is unable to
return EFCs certificates.


