active during any portion of the calendar year. The RAFs form was mailed to PCS for the period of January 1 through December 31. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. PCS was scheduled to remit its RAFs by January 31, 2000. As of August 29, 2000, PCS had not paid the required fees.

After this docket was opened, on September 20, 2000, Mr. Alex Valencia, representative of PCS, called our staff and advised that the past due amount would be paid, and PCS would propose a settlement offer. On September 29, 2000, we received the 1999 RAFs, including accrued statutory penalties and interest charges, and a settlement proposal. PCS offered to contribute \$200 to the State General Revenue Fund, and proposed to pay future RAFs on a timely basis.

We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. PCS must comply with these requirements within ten business days from the date this Order becomes final. The contribution should be identified with the docket number and the company name. Upon timely receipt, the contribution will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. Upon remittance of the \$200 contribution or cancellation of the certificate, this docket shall be closed.
