Dear Mr. Wenz:

This letter is a follow-up to an earlier telphone conversation between you and Ms. Stephanie Clapp, a member of my staff. The subject of your conversation was the need for additional information as to the amount of the Bartelt Sunshine (Sunshine) system contributions-in-aid-ofconstruction (CIAC) to be reflected in rate base. Pursuant to Rule 25-30.570, Florida Administrative Code:

If the amount of CIAC has not been recorded on the utility's books and the utility does not submit competent substantial evidence as to the amount of CIAC, the amount of CIAC shall be imputed to be the amount of plant costs charged to the cost of land sales for tax purposes if available, or the proportion of the cost of the facilities and plant attributable to the water transmission and distribution system and the sewage collection system.

According to previous orders and the Public Service Commission (PSC) audit of Sunshine, Sunshine was a developer-owned utility serving 1,055 customers at the time the PSC received jurisdiction in Pasco County on July 11, 1972. According to Order No. 6394, issued December 12, \(\frac{1}{12} \) 1974, in Docket No. 74058-W, Sunshine had a connection fee of \$65 at that time. When the connection fees were collected, they should have been recorded as CIAC. We need the utility to provide information on whether the fees were collected and how were they were treated on the utility's books.
