## ORDER RECONSIDERING VOTE AND APPROVING COLLOCATION AMENDMENT TO EXISTING INTERCONNECTION, UNBUNDLING, AND RESALE AGREEMENT

BY THE COMMISSION:

On September 21, 2000, BellSouth Telecommunications, Inc. (BellSouth) and DIECA Communications, Inc. d/b/a Covad Communications Company (Covad) filed a request for approval of a collocation agreement pursuant to 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The docket was scheduled to go to the December 19, 2000, Agenda Conference. On that date we approved staff's recommendation. However, after the vote, our staff determined that there were technicalities within the filing that warranted further review. After said review, our staff determined that this filing is a collocation amendment to BellSouth and Covad's existing interconnection, unbundling, and resale agreement. Therefore, we find it appropriate to reconsider our vote at the December 19, 2000, Agenda Conference. The amendment to the existing agreement is incorporated by reference herein. A copy

of the amendment to the existing agreement may be obtained by contacting our Division of Records and Reporting.

The Act encourages parties to enter into negotiated agreements. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The existing agreement governs the relationship between the companies regarding local interconnection and the exchange of traffic pursuant to 47 U.S.C. § 251. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement.

Upon review of the proposed collocation amendment to the existing agreement, we believe that it complies with the Act; thus, we hereby approve it. The Commission's approval of this agreement should not be construed as a determination that BellSouth has met the requirements of Section 271 of the Act. BellSouth and Covad are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that we hereby reconsider our vote at the December 19, 2000, Agenda Conference and approve the collocation amendment to the existing interconnection, unbundling, and resale agreement between BellSouth Telecommunications, Inc. and DIECA Communications, Inc. d/b/a Covad Communications Company, incorporated by reference in this Order. A copy of the agreement may be obtained as specified in the body of this Order. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this Docket shall be closed.
