The Commission received your letter dated January 23, 2001 requesting cancellation of your pay telephone certificate. You stated that you understood you are responsible for the 2000 Regulatory Assessment Fee (RAF), however, there was no check attached with the letter.

Since the 2000 RAF was due by January 30, 2001, this means that in addition to the minimum RAF (\$50.00), you also owe statutory penalty (\$2.50) and interest (\$0.50) charges, for a total of \$53.00 for 2000.
