Dear Ms. Clapp:

This letter addresses the following requirement which was specified in the commission's Order Approving Transfer, Requiring Accounts and Records to be Maintained in Conformance with the NARUC Uniform System of Accounts and Notice of Proposed Agency Action Order Establishing Rate Base for Purposes of the Transfer, No. PSC-01-0428-PAA-WS, issued on February 22, 2001, in the above docket:

"ORDERED that CWS Communities LP d/b/a Crystal Lake Club shall maintain the utility's books and records in-state or request the requisite authorization from the Commission by March 31, 2001, with its 2000 annual report, to continue to maintain its books and records out-of-state."

With regard to this language, it has been determined that the Utility shall maintain its books and records in-state. Although the actual accounting is done in CWS's El Paso, Texas accounting headquarters, all original invoices are kept in Florida, and hard copies of all books and records will be sent on a monthly basis to the utility in Florida. These books and records are also accessible by computer in Florida, with assistance from Texas accounting personnel. The books and records will be maintained in an orderly manner at the park office such that PSC auditors may access the information as needed.
