Arch Wireless, Inc. in response to the above listed Commission order submits the information requested in Cheryl R. Bulecza-Banks letter dated August 17, 2000. The letter was directed to PageNet, a company acquired by Arch Wireless, Inc. during November of the year 2000.

Arch provides through various subsidiaries such as PageNet and others (Collectively, "Arch") paging and other data messaging services- a set of services generally classified as Narrowband Personal Communications Services. The Federal Communications Commission has ruled that Paging Carriers do not have the obligation to provide local number portability (LNP) with any of its services, including two-way services. It appears that the emphasis of the above referenced order seeks information from those Communications Carriers providing "voice" services and those that are required to be, or become Local Number Portability Capable. However, we have supplied the information requested as we share the Commissions desire for optimization in Number Utilization and Conservation.

The enclosed data contains highly sensitive commercial information that would place Arch at a competitive disadvantage if the data is disclosed, particularly to existing or potential competitors. Arch, therefore, asks, that the Commission treat the data as confidential and that it not disclose the information to anyone other than those within the Commission with a "need to know".
