



Dear Mr. Cummins:

The Commission has received your request for cancellation of your pay telephone certificate, along with your check for the 2001 Regulatory Assessment Fee (RAF). There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the RAF, including statutory penalty and interest charges. The other is involuntary. If a company is not in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. Any balance owed is forwarded to the Comptroller's Office for collection.

According to Commission records, your company has an outstanding balance in the amount of \$6.00 for penalty and interest charges. A breakdown of the charges is attached. Therefore, based on the above information, I cannot recommend a voluntary cancellation of your certificate unless the past due balance is paid. As soon as your check for the \$6.00 balance is received, a docket will be opened to cancel your certificate voluntarily.
