Abrahams d/b/a South Atlantic Telecom (South Atlantic Telecom), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 7002, has requested the cancellation of PATS Certificate No. 7002. South Atlantic Telecom has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly, we find it appropriate to cancel PATS Certificate No. 7002, effective December 31, 2000. South Atlantic Telecom shall return to this Commission the Order granting authority to provide PATS services. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

ORDERED that Edward J. Abrahams d/b/a South Atlantic Telecom shall return to this Commission the Order granting authority to provide Pay Telephone services. It is further
