BY THE COMMISSION:

Allan Bennett Corporation, holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 2556, has requested the cancellation of PATS Certificate No. 2556. Allan Bennett Corporation has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly, we find it appropriate to cancel PATS Certificate No. 2556, effective March 6, 2001. Allan Bennett Corporation shall return to this Commission the Order granting authority to provide PATS services. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2001 will be mailed to Allan Bennett Corporation. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2001 shall relieve Allan Bennett Corporation from its obligation to pay RAFs for the year 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Allan Bennett Corporation's Certificate No. 2556 to provide Pay Telephone services is hereby canceled, effective March 6, 2001. It is further

The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
