Re: Notice of Termination of Agreement to Transfer Control of Genesis Communications International, Inc. to American TeleSource International, Inc.; **Docket No. 000903-TP**

Dear Ms. Bayo:

On behalf of Genesis Communications International, Inc. ("Genesis") and American TeleSource International, Inc. ("ATSI") (together, the "Parties"), this letter is to notify the Commission that the Parties have agreed to a mutual termination of the agreement whereby ATSI was to acquire control of Genesis. Genesis and ATSI's subsidiary, also known as American TeleSource International, Inc. (a corporation organized under the laws of the State of Texas), are nondominant carriers authorized by the Commission to provide telecommunications services in the State of Florida.

The Commission previously granted the Parties' request for approval of the proposed transaction by Order No. PSC-00-1923-CO-TP, issued on October 19, 2000 in Docket No. 000903-TP. Recently, however, the Parties concluded that termination of the transaction was necessary due to certain delays beyond the Parties' control that have made it impossible to conclude the merger within a reasonable time.
