

**REQUEST FOR CONFIDENTIAL CLASSIFICATION**

Southern Company-Florida LLC ("Southern-Florida"), with the agreement and consent of the Orlando Utilities Commission ("OUC"), the Kissimmee Utility Authority ("KUA"), and the Florida Municipal Power Agency ("FMPA") (collectively the "Applicants"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(4), Florida Administrative Code, respectfully requests that the Florida Public Service Commission (the "Commission") classify as confidential certain specified information in the following three final, executed Power Purchase Agreements (the "PPAs"):

- (1) Power Purchase Agreement Between Orlando Utilities Commission and Southern Company-Florida LLC Dated as of March 19, 2001;
- (2) Power Purchase Agreement Between Kissimmee Utility Authority and Southern Company-Florida LLC Dated as of March 19, 2001; and
- (3) Power Purchase Agreement Between Florida Municipal Power Agency (All Requirements Power Supply Project) and Southern Company-Florida LLC Dated as of March 19, 2001.

The PPAs are being submitted to the Commission in support of the Applicants' Joint Petition for Determination of Need for proposed Stanton Energy Center Combined Cycle Unit A to the Curtis H. Stanton Energy Center ("Need Petition"). In support of its request for confidential classification, Southern-Florida states:

1. On January 31, 2001, the Applicants filed their Need for Power Application ("NPA") in this docket. Draft PPAs to be executed by the Applicants were appended to the NPA and were the subject to a Request for Confidential Classification filed by Southern-Florida with the Commission on the same date the NPA was filed. Section 1A.4.0 of the NPA states: "Final executed copies of the PPAs will be provided to the Commission upon their execution." The PPAs have been finalized and executed and are now being filed with the Commission, subject to this Request for Confidential Classification, in accordance with Section 1A.4.0.

2. The PPAs include certain confidential pricing information, trade secrets and other sensitive contract terms and conditions that have been negotiated by the parties. Accordingly, the PPAs are being filed in redacted form to protect certain specified sensitive confidential information.

3. The specified sensitive, confidential information in the PPAs is entitled to confidential classification, pursuant to Section 366.093(3), Florida Statutes, and Rule 25-22.006, Florida Administrative Code, and is exempt from Section 119.07(1), Florida Statutes, and Article I, Section 24(a) of the

Florida Constitution, because it is proprietary confidential business information.

4. Section 366.093(3) provides that proprietary confidential business information is:

information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to . . . the person or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

§ 366.093(3), Fla. Stat. (2000).

5. The disclosure of the specified sensitive, confidential information in the PPAs would harm the competitive business position of Southern-Florida. Specifically, if the confidential, competitively sensitive information in the PPAs is made public, it will be available to actual or potential competitors, vendors and customers of Southern-Florida and/or its affiliates. Disclosure of the sensitive, confidential information in the PPAs to anyone other than the Applicants, and those employees of the Commission that need to review the information as part of the need determination proceeding, would harm Southern-Florida's competitive interests, particularly its ability to negotiate and enter into similar contracts on reasonable business terms. Accordingly, the information constitutes proprietary confidential business information entitled to protection from disclosure pursuant to Section

366.093(1)(3)(e), Florida Statutes, and Rule 25-22.006, Florida Administrative Code.<sup>1</sup>

6. Seven edited copies of the PPAs with the confidential information subject to this request redacted are being filed with the Commission contemporaneously with this Request for Confidential Classification. Only these redacted copies of the PPAs may be made available for inspection by the public.

7. The following documents explaining this request are attached hereto and incorporated by reference herein:

Exhibits A-1 through A-3: Justification "matrices" for each of the PPAs supporting Southern-Florida's Request for Confidential Classification of the confidential information redacted in each PPA, identified on a page-by-page, line-by-line basis.

Composite Exhibit B: The PPAs with the confidential information subject to this request highlighted in transparent ink. This document has been placed in a sealed envelope marked "Confidential" and should be given confidential treatment by the Commission. There is only one copy of this Composite Exhibit B, which is attached to the original filing copy hereof.

8. Pursuant to Rule 25-22.006(4)(d), Florida Administrative Code, Southern-Florida affirms that the material identified as confidential in

<sup>1</sup> The specified sensitive and confidential information in the PPAs is also exempt from Section 119.07(1) as proprietary confidential business information as that phrase is defined in Section 163.01(15)(m), Florida Statutes, which is part of the Florida Interlocal Cooperation Act of 1969, as amended.

Composite Exhibit B hereto is intended to be and is treated by Southern-Florida as confidential. The undersigned has conferred with the other Applicants and is authorized to represent that all of the Applicants affirm that the subject material identified as confidential in Composite Exhibit B is intended to be and is treated by the Applicants as confidential.

9. Pursuant to Section 366.093(4), Florida Statutes, Southern-Florida further requests that the specified confidential information in the PPAs be classified by the Commission as confidential for the maximum period of 18 months, and that the unredacted copies of the PPAs in the envelope marked "Confidential" be returned promptly to Southern-Florida upon the closure of this docket.

WHEREFORE, Southern-Florida respectfully requests that the information contained in the PPAs and identified as confidential in Composite Exhibit B hereto be classified as confidential and exempt from the Public Records Act, Chapter 119, Florida Statutes, and Article I, Section 24(a) of the Florida Constitution.


