JOINT MOTION FOR EXTENSION OF TIME

NOW Comes, BellSouth Telecommunications, Inc. ("BellSouth") and Global NAPs South, Inc. ("Global NAPs"), who jointly ask this Commission for a thirty (30) day extension of time or until May 25, 2001 in which to execute and file an interconnection agreement. Pursuant to Order No. PSC-01-0762-FOF-TP, the parties are required to file a final executed interconnection agreement with the Commission on April 25, 2001. The parties need additional time to negotiate the final agreement. As both parties are seeking this extension, no party will be prejudiced by the granting of an additional thirty (30) days in which to file a final interconnection agreement with the Commission.
