STIPULATION FOR EXTENSION OF TIME TO FILE RESPONSES

AT&T Communications of the Southern States, Inc., TCG South Florida, and MediaOne Florida Telecommunications, Inc. (collectively, "AT&T"); the Florida Competitive Carriers Association ("FCCA") and BellSouth Telecommunications, Inc. ("BellSouth") have agreed upon an extension of time until May 2, 2001 for AT&T and FCCA to respond to BellSouth's Motion to Dismiss, or in the alternative, Motion to Strike AT&T's Petition Seeking the Structural Separation of BellSouth Telecommunications, Inc. as well as BellSouth's Motion to dismiss, or in the alternative, motion to strike FCCA's request for Commission investigation concerning use of structural incentives to open local telecommunications markets. Having reached this agreement, AT&T and BellSouth have further agreed to withdraw their motions and responses related to this issue.

Counsel for BellSouth and FCCA have reviewed this Stipulation, have agreed to its form and content, and join AT&T in asking the Commission to approve this Stipulation.
