NOTICE OF PROPOSED AGENCY ACTION ORDER CANCELING PAY TELEPHONE CERTIFICATE INVOLUNTARILY

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Statewide Services Corporation of W.H. (Statewide Services Corporation) currently holds Certificate of Public Convenience and Necessity No. 7442, issued by the Commission on June 16, 2000, authorizing the provision of Pay Telephone service. Statewide Services Corporation has not paid the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 2000. Also, accrued statutory penalties and interest charges for the year 2000 have not been paid.

Pursuant to Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was

active during any portion of the calendar year. Pursuant to Rule 25-4.0161 (2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. All entities that apply for certification receive a copy of our rules governing Pay Telephone service.

Pursuant to Section 350.113(4), Florida Statutes, the RAFs forms, for the period of January 1, through December 31, are mailed to the entities at least 45 days prior to the date that payment of the fee is due. Statewide Services Corporation was scheduled to remit its RAFs by January 30, 2001.

On November 7, 2000, we received a letter from Statewide Services Corporation's president, Mr. Dan Kilburn requesting the cancellation of its certificate. Our staff called, e-mailed, and wrote Statewide Services Corporation several times since the request for cancellation was not in compliance with Rule 25-24.514, Florida Administrative Code. All attempt to contact Statewide Services Corporation were unsuccessful.

As of March 28, 2001, Statewide Services Corporation has neither paid the 2000 RAFs, along with accrued statutory penalty and interest charges, nor advised when the fee would be paid.

Statewide Services Corporation has not complied with Rule 25-24.514(2), Florida Administrative Code, which states:

- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request:
- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.

Accordingly, since the company's certificate remains active until it requests a voluntary cancellation pursuant to Rule 25-24.514(2), Florida Administrative Code, or we involuntarily cancel the certificate, Statewide Services Corporation is responsible for

the RAFs. As of the date of the vote, Statewide Services Corporation continues to be in violation of our rules for nonpayment of RAFs for the year 2000.

For the reasons described above, pursuant to Rule 25-24.514(1)(b) and (c), Florida Administrative Code, we deny Statewide Services Corporation's request for voluntary cancellation of Pay Telephone Certificate No. 7442 for failure to comply with the provisions of Rule 25-24.514(2), Florida Administrative Code. However, we find it appropriate to involuntarily cancel Statewide Services Corporation's certificate, effective date of issuance of the Consummating Order, for failure to pay RAFs pursuant to Section Florida Statutes, and Rule 25-4.0161, Administrative Code. Statewide Services Corporation shall return to this Commission the Order granting authority to provide Pay Telephone services.

Since Statewide Services Corporation is no longer in business, there would be no purpose in requiring Statewide Services Corporation to pay a fine. By involuntarily canceling Statewide Services Corporation's certificate, however, we would be able to track this company should it apply for another certificate with us in the future. The cancellation of the certificate and the closing of the Docket in no way diminishes Statewide Services Corporation's obligation to pay applicable delinquent RAFs, statutory penalties, and interest charges. The collection of the past due fees shall be referred to the Office of the Comptroller for further collection efforts. The Commission is vested jurisdiction over this matter pursuant to Sections 364.336 and 364.285, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that we hereby deny Statewide Services Corporation of W.H.'s request for voluntary cancellation of Pay Telephone Certificate No. 7442. It is further

ORDERED that pursuant to Rule 25-24.514(1)(b) and (c), Florida Administrative Code, we hereby cancel Statewide Services Corporation of W.H.'s Pay Telephone Certificate No. 7442, effective date of issuance of the Consummating Order, for failure to comply with Rule 25-24.514(2), Florida Administrative Code; Section 364.336, Florida Statutes; and Rule 25-4.0161, Florida

Administrative Code. It is further

ORDERED that Statewide Services Corporation of W.H. shall return to this Commission the Order granting authority to provide Pay Telephone services. It is further

ORDERED that Statewide Services Corporation of W.H. remains obligated for all due and owing Regulatory Assessment Fees for the year 2000, as well as accrued statutory penalties and interest charges. The collection of the past due fees shall be referred to the Office of the Comptroller for further collection efforts. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed.

This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on May 28, 2001.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
