On April 11, 2001, Talk.com Holding Corp. amended its Articles of Incorporation to change its name to Talk America, Inc. ("Company"). This name change reflects the Company's nationwide reach, and will allow the company to have all of its entities to operate under one brand name. The Company is currently authorized to provide Alternative Local Exchange Services in Florida under Certificate Number 4692 and Toll Service under Certificate Number 2985. This amendment changed only the name of the corporation and did not alter any assets or holdings, the Company's corporate structure, nor its personnel, directors and officers. Additionally, the Company has not altered its service offerings or prices, so its customers should not be adversely affected by this name change.
