Dear Ms. Daniel:

As promised in my April 25, 2001 letter supplementing my March 30, 2001 letter answering questions posed by your February 12, 2001 letter, I enclose the corrected water and wastewater tariffs which have been revised to conform with the suggestions of PSC staff.

No form invoice is concluded in that due to the flat rates agreed upon between the utility and the cooperative that owns the Forest Lakes Mobile Home and RV community, Labrador Services, Inc. has determined that monthly invoices are not needed at this time. New residents to the community are advised by management of the charge for utility service and where to direct their payment. Existing residents are already familiar with the charges and where to mail their monthly checks. Under these circumstances, Labrador has determined that it is not cost effective to send invoices under the current flat rate structure. This will certainly change once usage rates are approved by the PSC and instituted by Labrador Services, Inc.
