COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. On May 8, 2001, Covad Communications Company ("Covad") served its Second Set of Interrogatories and First Request for Production on BellSouth. On May 18, 2001, BellSouth filed its Objections to that discovery and on May 23, 2001, BellSouth served its Responses and Objections to that discovery.


3. Because this information is proprietary, BellSouth is now filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule
