## ORDER APPROVING ADOPTION OF INTERCONNECTION, UNBUNDLING, AND RESALE AGREEMENT

BY THE COMMISSION:

On May 8, 2001, Sprint-Florida, Incorporated (Sprint-Florida) and DSLnet Communications, LLC (DSLnet Communications) filed a notice of adoption in its entirety of the Interconnection, unbundling, and resale agreement entered into and between Sprint-Florida and MGC Communications, Inc. d/b/a Mpower Communications, Corp., pursuant to 47 U.S.C. §252(i) of the Telecommunications Act of 1996 (the Act). This agreement was approved by the Commission by Order No. PSC-00-1504-FOF-TP, issued on August 18, 2000, and is incorporated by reference herein. A copy of the agreement may be obtained by contacting our Division of Records and Reporting.

The Act encourages parties to enter into negotiated agreements. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(i) requires that a local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved by the state commission to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety. Further, Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The adoption of this agreement shall be effective on the date of issuance of this Order and will expire on the date specified in the agreement. This agreement governs the relationship between the companies regarding local interconnection and the exchange of

traffic pursuant to 47 U.S.C. § 251. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement.

Upon review of the proposed adoption, we find that it complies with the Act; thus, we hereby approve it. Sprint-Florida and DSLnet Communications are also required to file any subsequent supplements or modifications to this agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Sprint-Florida, Incorporated and DSLnet Communications, LLC's adoption in its entirety of Sprint-Florida, Incorporated and MGC Inc. Communications, d/b/a Mpower Communications, Corp.'s interconnection, unbundling, and resale agreement, incorporated by reference in this Order, is hereby approved. A copy of the agreement may be obtained as specified in the body of this Order. It is further.

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket is hereby closed.
