Dear Ms. Bayo:

The above-referenced docket was opened in connection with a transfer application filed with respect to Florida Water's purchase of Spruce Creek Utilities, Inc. The terms and conditions of the purchase are reflected in an Asset Purchase Agreement which is Exhibit D to the Transfer Application. The parties to the purchase have jointly sought Commission approval of several ancillary agreements which are an integral part of the sale. As a result, there are many interrelated issues that will be addressed in the staff recommendation in this docket. As part of the transfer, Florida Water filed on April 23, 2001 an Application for Approval of a New Class of Service dealing specifically with reclaimed water. This letter will confirm that Florida Water waives the 60-day time limit prescribed in Section 367.091(6), Florida Statutes, with respect to the new class of service for reclaimed water. This should help ensure the timely, complete and efficient examination of all the matters raised with respect to the Application in one staff recommendation for consideration by the Commission.
