

Dear Ms. Perry:

On May 16, 2001, the Commission received your payment of the \$21.00 past due penalty and interest charge for the years 1998, 1999, and 2000, along with the 2001 Regulatory Assessment Fee (RAF) return form for the period January 1 through December 31, 2001 period. You had marked through the period covered and wrote "The phones have lost money all year. They were out of order for 9 months. I closed down last Sept. 2000."

A certificate remains active until the company notifies the Commission to cancel a certificate. In addition, even if you lost money or, in fact, never installed any payphones, the RAF is owed if the certificate is active for any day during a calendar year. This means that the 2001 RAF is still owed since we did not receive your request for cancellation until April 26, 2001. I'm sorry that you're ill and lost money in the payphone business. Unfortunately, since the RAF is mandated by statute, I cannot waive the 2001 RAF.

Unless I hear from you by the end of June 2001, I will write a recommendation to deny a voluntary cancellation of your certificate and the unpaid 2001 RAF will be forwarded to the Comptroller's Office for collection.
