Re: Approval of an Amendment to the Interconnection, Unbundling, Resale and Collocation Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Phone-Link, Inc. pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Phone-Link, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Phone-Link, Inc. The Commission approved the initial agreement between the companies in Order No. 01-1251-FOF-TP issued June 5, 2001 in Docket 010520-TP. This amendment adds Exhibit A to Attachment 7 of the agreement.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and Phone-Link, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

## AMENDMENT TO THE INTERCONNECTION AGREEMENT BETWEEN PHONE LINK, INC. AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED MARCH 12, 2001

Pursuant to this Amendment, (the "Amendment"), Phone Link, Inc. and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred collectively as the "Parties", hereby agree to amend that certain Interconnection Agreement between the Parties dated March 12, 2001 ("Agreement")

WHEREAS, BellSouth and Phone Link, Inc. entered into the Agreement on March 12, 2001, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

- 1. The Parties agree to add Exhibit A, attached hereto as Exhibit 1, to Attachment 7 of the Agreement.
- 2. All of the other provisions of the Agreement, dated March 12, 2000, shall remain in full force and effect.
- Either or both of the Parties is authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252
  (e) of the Federal Telecommunications Act of 1996.
