DISCUSSION OF ISSUES

ISSUE 1: Should the Commission grant St. Joe Natural Gas Company, Inc.'s (St. Joe) request for an extension of time, until June 30, 2001, to file its Annual Report?

Yes. RECOMMENDATION: The Commission should grant St. Joe's request for an extension to June 30, 2001, to file its Annual Report. (SLEMKEWICZ)

STAFF ANALYSIS: On May 22, 2001, St. Joe requested an extension of time, until June 30, 2001, to file its Annual Report. (Attachment) Rule 25-7.135, Florida Administrative Code, requires investor-owned natural gas utilities to file annual reports by April 30 of each year following the reporting year. One extension of 31 days will be granted upon request. St. Joe requested, and was granted, a 31 day extension. Any requests for a longer extension must be

approved by the Commission and be accompanied by a statement of good cause and specify a filing date.

St. Joe states in its request that an additional extension of time is necessary because its auditor is still awaiting a response from the Internal Revenue Service concerning a change in accounting method. St. Joe further asserts that this response is needed in order for it to close its books for the year ended December 31, 2000. Based on this information, Staff believes that St. Joe's request is reasonable and recommends that the request be granted. It should be noted that St. Joe's current financial status was thoroughly reviewed in its recently concluded rate case in Docket No. 001447-GU.

ISSUE 2: Should this docket be closed?

RECOMMENDATION: If no person whose substantial interests are affected by the proposed agency action files a protest within 21 days of the issuance of the order, this docket should be closed upon the issuance of a consummating order. (WALKER)

STAFF ANALYSIS: At the conclusion of the protest period, if no protest is filed, this docket should be closed upon the issuance of a consummating order.
