NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELING INTEREXCHANGE
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

Opus Correctional, Inc. d/b/a LocTel (LocTel), holder of
Interexchange Telecommunications Certificate (IXC) of Public
Convenience and Necessity No. 3131, has requested the cancellation
of IXC Certificate No. 3131. LocTel has complied with the
provision of Rule 25-24.474(2), Florida Administrative Code, by
providing adequate notice in writing of its request for
cancellation of its IXC certificate and by submitting its
Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly,
we find it appropriate to cancel IXC Certificate No. 3131,
effective March 16, 2001. LocTel shall return to this Commission
the Order granting authority to provide IXC services. The

Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2001 will be mailed to LocTel. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2001 shall relieve LocTel from its obligation to pay RAFs for the year 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Opus Correctional, Inc. d/b/a LocTel's Certificate No. 3131 to provide Interexchange Telecommunications services is hereby canceled, effective March 16, 2001. It is further


ORDERED that Opus Correctional, Inc. d/b/a LocTel shall return to this Commission the Order granting authority to provide Interexchange Telecommunications services and remit Regulatory Assessment Fees for the year 2001. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing that is available under Section 120.57, Florida Statutes, as well as the procedures and time limits that apply. Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code.
