Dear Mr. Philip:

During my April 23 telephone conversation with you, I was told that since you were no longer in the pay telephone business, you would pay the 2000 and 2001 Regulatory Assessment Fees and write a letter requesting cancellation of your pay telephone certificate. According to Commission records, we received your letter on May 3, 2001, requesting cancellation, however, payment for the 2000 Regulatory Assessment Fee (RAF), including statutory penalty and interest charges, was not attached.

It is my intention to file a recommendation to fine Gregory A. Philip d/b/a GAPTEL \$500 for violation of Rule 25-4.0161, Florida Administrative Code, if payment for the past due amount is not received by June 29, 2001. In addition, the company needs to either pay the 2001 RAF or provide a date certain it will be paid. A breakdown is attached.
