## ORDER AMENDING ORDER NO. PSC-01-1167-PAA-WS AND RESCINDING ORDER NO. PSC-01-1311-PAA-WS

BY THE COMMISSION:

On May 22, 2001, we issued Order No. PSC-01-1167-PAA-WS, approving the transfer of assets, facilities, and Certificates Nos. 524-W and 459-S from Arbor Oaks I, LLC and Arbor Oaks II, LLC both Delaware Limited Liability Companies d/b/a Timberwood Utilities to Mink Associates I, LLC d/b/a Timberwood Utilities (Mink Associates or utility). Due to a scrivener's error, the utility's existing monthly gallonage charge for wastewater service was misstated in the Order as \$1.42 per thousand gallons for residential customers and \$1.71 per thousand gallons for general service customers. Order No. PSC-01-1167-PAA-WS is amended to reflect that the utility's existing monthly gallonage charge for wastewater service is \$5.16 per thousand gallons for residential customers and \$6.18 per thousand gallons for general service customers.

Also, on June 18, 2001, Order No. PSC-01-1311-PAA-WS was issued in this docket in error. Order No. PSC-01-1311-PAA-WS is hereby rescinded.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-01-1167-PAA-WS is hereby amended to reflect that Mink Associates I, LLC d/b/a Timberwood Utilities' existing monthly gallonage charge for wastewater service is \$5.16 per thousand
