At the June 11, 2001, prehearing conference, as reflected in Order No. PSC-01-1368-PHO-TL, issued June 26, 2001, the prehearing officer required BellSouth to file a Specified Request for Confidential Classification of any information currently covered by a "claim" of confidential treatment that it wished to remained protected as such in this Docket. Any other information for which BellSouth did not specifically request confidential treatment in its filing was to be declassified. On June 21, 2001, BellSouth filed its Request for Confidential Classification. Therein, BellSouth requested confidential treatment of certain exhibits submitted by OPC's witness Earl Poucher. Those exhibits are as follows: REP-6, REP-18, REP-19, REP-20, REP-21, REP-25, REP-26, REP-27, REP-29, REP-39, REP-40 and REP-42. These documents should continue to be treated as confidential until rule upon by the prehearing officer. Furthermore, it is unclear as to whether REP-15 is covered by this request at this time.
