COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. In a letter dated June 13, 2001, the Florida Public Service Commission (the "Commission"), requested BellSouth to provide information on LEC LNP order processes and LEC rules & restrictions about customer telephone number retention.
