This letter is written to clarify that NOW Communications, Inc., ("NOW") will operate in Florida pursuant to its interconnection agreement with BellSouth Telecommunications, Inc., which was filed for approval with the Commission on June 4, 2001, in the above-referenced docket, only as NOW Communications, Inc.

NOW will use no other fictitious names. NOW's Certificate No. 5652 was amended by Order No. PSC-01-1107-FOF-TX, issued May 15, 2001, in Docket No. 010701-TX, to withdraw the fictitious name Tel-Link, LLC. Project Management Solutions, Inc., d/b/a as Talk Solutions' Certificate No. 7155 was cancelled by Order Nos. PSC-01-0207-PAA-TX, issued January 3, 2001, and PSC-01-0473-CO-TX, issued February 26, 2001, in Docket No. 001484-TX. TelStar International, Inc. d/b/a Telstar Long Distance, Inc.'s Certificate No. 5278 was cancelled by vote of the Commission on June 25, 2001, in Docket No. 010700-TP.
