JEA (f/k/a Jacksonville Electric Authority) pursuant to the Order approving Territorial Agreement between it and Clay Electric Cooperative, Inc. ("Clay") dated October 26, 1992, does hereby report to the Florida Public Service Commission that the following transfers have occurred during JEA's fiscal year, October 1, 1999 - September 30, 2000, and through May 31, 2001.


1. On August 5, 2000, Clay transferred 5 customers to JEA.
2. On November 7, 2000, JEA transferred 34 to Clay.
3. On May 22, 2001, Clay transferred 465 customers to JEA. This does not agree with data submitted by Clay because, of the 493 customers reported by Clay, 28 ceased service prior to transfer.


