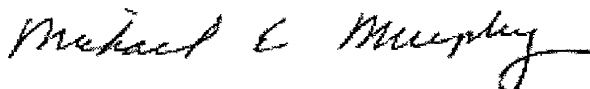
In accordance with the April 16, 2001 Order, a refund of \$1,030,401.16, including interest of \$183,502.31 was calculated for former customers of the North Ft. Myers Division of Florid Cities Water Company. Refunds and interest were calculated in accordance with the Order and Rules for Refunds.

Refund checks were mailed to 2,117 customers on the system as of November 13, 1999 on May 16, 2001 in accordance with the Order. These refund checks totaled \$745,897.64, including interest of \$132,839.13.

Additionally during May the Refund was advertised, on May 3, 10, 17 and 24 in the Ft. Myers News-Press, in accordance with the Order. Former customers who did not receive a refund check because they were not on the system as of November 13, 1999 will have their refund calculated, with interest, and a refund check will be mailed to them in accordance with the Order. As of July 19, 2001, 25 customers have contacted us regarding a refund and as a result additional refund checks, including interest, totaling \$5,028.28 have been mailed.

As of June 30, 2001, 2,051 checks totaling \$732,972.06 had cleared the bank account. As of July 19, 2001, 17 checks, totaling \$3,651.62, have been returned as undeliverable and are in the process of being investigated to determine if a better address can be located. As of July 19, 2001, a total of 98% of the checks mailed have either cleared the bank or been returned as undeliverable.
