

## NewSouth Communications Corp.'s Notice of Withdrawal of Letter of May 8, 2001 or in the Alternative, Petition for Formal Proceeding

NewSouth Holdings, Inc. and NewSouth Communications Corp. (NewSouth) hereby

withdraw their letter of May 8, 2001 requesting cancellation of the certificates and tariffs of

UniversalCom, Inc. (UCI,), request that the proposed agency action (PAA) order entered on June 28,

2001 canceling such certificates be of no force and effect, and that the UCI certificates remain in

effect until further notice. As grounds therefore, NewSouth states:

4. **Explanation of substantial interests**. By letter dated May 8, 2001, NewSouth provided supplemental notification to the Commission that the planned merger between NewSouth and UCI had been completed and that cancellation of the certificates and tariffs of UCI should occur. On June 28, 2001, the Commission issued PAA Order No. PSC-01-1380-PAA-TP granting that request and canceling UCI certificate numbers 4096 and 3174. It has now come to NewSouth's attention that there was an error in its letter of May 8 and that the merger between the two companies is **not** yet complete, though consummation of the merger is expected shortly. Therefore, UCI's certificates should **not** be canceled at this time. To prematurely cancel UCI's certificates prior to the completion of the merger would affect the substantial interests of both companies.

5. Because the PAA order was issued as the result of a request by NewSouth, NewSouth's notice of withdrawal of its request renders the PAA order a nullity and of no force and effect, thus leaving the UCI certificates in full force and effect.<sup>1</sup> However, in an abundance of caution, NewSouth files this protest so as to ensure that the PAA order does not take effect.

6. The UCI merger is currently scheduled to take effect shortly. When it does, NewSouth will promptly inform the Commission and reinstate its request for the cancellation of the UCI certificates at that time. Alternatively, NewSouth suggests that the Commission simply keep

this file open pending notification that the merger has been completed.

7. **How notice received**. Notice of the PAA order was received via the Commission website.

8. **Disputed issues of material fact**. There are no disputed issues of material fact.

9. <u>Ultimate facts alleged</u>. Ultimate facts alleged are that cancellation of the UCI certificates is premature at this time.

WHEREFORE, NewSouth hereby withdraws its letter of May 8, 2001 requesting the cancellation of the UCI certificates, requests that PAA Order No. PSC-01-1380-PAA-TP be rendered a nullity and of no force and effect, and that the UCI certificates remain in effect. In the alternative, NewSouth suggests that this docket simply remain open pending notification of consummation of the merger. Finally, in an abundance of caution, NewSouth requests a formal proceeding on Order No. PSC-01-1380-PAA-TP, to the extent necessary.
