ISSUE 1: Should the Commission grant Nancy Lynn Perry a voluntary cancellation of Certificate No. 5476?
RECOMMENDATION: No. The Commission should not grant the company a voluntary cancellation of its certificate. The Commission should cancel the company's Certificate No. 5476 on its own motion, effective April 26, 2001.

ISSUE 2: Should this docket be closed?
