## NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

The Southern Company and Gulf Power Company, by and through their undersigned attorney and pursuant to Rule 25-22.006, Florida Administrative Code, hereby gives notice that they intend to request confidential classification for Form U-9C-3 for the period ending March 31, 2001, submitted to the Florida Public Service Commission Staff pursuant to Securities and Exchange Commission Rule 104. A copy of Form U-9C-3 for the period ending March 31, 2001, is attached hereto as exhibit "A".
