This letter is to confirm that Gulf has provided a response the Office of Public Counsel for each of the Citizen's Third Request for Production of Documents to Gulf Power (Nos. 3-7). The documents requested in request numbers 3- 5 were provided to all parties of record at the August 1, 2001 status conference as exhibits to supplemental pre-filed direct testimony.
