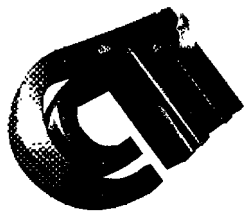

Please find enclosed the year 2000 Interexchange Company Regulatory Assessment Fee Return for Eastern Tel Long Distance Service, Inc. ("Eastern") along with our check in the amount of \$66.00.

As previously discussed with Ms. Isler, all the issued and outstanding stock of Eastern was purchased by our company on November 22, 2000. Those individuals previously responsible for filing regulatory reports and all federal, state and local tax returns are no longer with the company. Unfortunately, the filing requirement for the Florida State Regulatory Assessment Fee (RAF) was not identified during our due diligence as a report to be filed. We regret this oversight prompted the need for Docket No. 011069-T1.

Now that we are aware of this filing requirement, we have included its preparation on our internal calendar of reports/taxes to be filed and with appropriate due dates.

To resolve this matter and continue its PSC Certificate No. 7502 in "good standing", Eastern proposes a settlement offer of \$500.00 along with our waiver of objection to the administrative cancellation of Eastern's certificate in the event our offer is accepted and we fail to comply with the terms we offered.

We appreciate your consideration in this matter and look forward to a positive acceptance of our settlement offer.
