

**JOINT MOTION FOR ORDER
REQUIRING REBUTTAL TESTIMONY
TO BE SERVED BY HAND OR ELECTRONIC DELIVERY**

Florida Power & Light Company ("FPL"), Florida Power Corporation ("FPC") and Tampa Electric Company ("Tampa Electric"), (collectively referred to as "Joint Movants") files this its Joint Motion to require any party filing rebuttal testimony in this docket to serve the Joint Movants by hand delivery no later than the date filed with the Commission and says:

1. The Commission's order establishing procedure entered jointly in each of the above-styled dockets on July 26, 2001 provides at page 2:

A copy of all prefiled testimony and exhibits shall be served by mail or hand delivery to all other parties and Staff no later than the date filed with the Commission.

2. Prefiled testimony is due to be filed on September 4, 2001 and rebuttal testimony is required to be filed on September 10, 2001. If Staff and Intervenor's testimony is served by mail, it could take five days or longer to receive the testimony in hand which could mean that the parties may never actually receive the testimony before the rebuttal is due.

3. Joint Movants request that the prehearing officer enter an order requiring all rebuttal testimony to be served by hand delivery, fax or e-mail on or before the day it is filed with the Commission.

4. Counsel for Mirant Americas Development, Inc., Calpine Corporation, Duke Energy, North America, CPV Atlantic, Ltd., PG&E, National Energy Group Company, Enron Corporation, Reliant Energy Power Generation, Florida Industrial Power Users Group, Office of Public Counsel, Florida Municipal Power Association (“FMPA”) and Mike Twomey, have stated they have no objection to this Motion.


